# **BUTTE CREEK**

### CALIFORNIA DEPARTMENT OF FISH AND GAME ANADROMOUS FISH RESTORATION AND CALFED PROGRAMS



## VISION

Local, broad-based watershed organization which facilitates restoration and long-term maintenance of watershed function, a component of which is achievement of anadromous fish restoration goals.

#### **Butte Creek Anadromous Fish Restoration**

The California Department of Fish and Game (CDFG) in coordination with other state and federal resource management agencies, water interests and local stakeholders, has since about 1992 implemented major restoration actions in the Butte Creek watershed. Restoration has been focused primarily upon anadromous fish, specifically the state and federally listed springrun Chinook salmon, and steelhead trout. State and federal legislation in the late 1980's, early 1990's provided guidance for restoration activities in the Central Valley. Specifically, the state Salmon, Steelhead Trout, and Anadromous Fisheries Program Act (1988), and federal Central Valley Project Improvement Act (PL 102-575, 1991) required that all reasonable efforts be made to restore and maintain anadromous fish populations on a long-term basis. Based upon this legislative direction, restoration plans were developed by CDFG (Restoring Central Valley Streams: A Plan for Action, November 1993), and the U.S. Fish and Wildlife Service (Anadromous Fisheries Restoration Program, 1998). The original legislative intent (state and federal), including the respective restoration plans, was subsequently incorporated in the CALFED Bay-Delta Program Record of Decision (August 2000) and the CALFED Ecosystem Restoration Program (August 2001). Effective January 1, 2003, the California Bay-Delta Authority was created to provide a governance structure for all CALFED programs, including the Ecosystem Restoration Program.

Butte Creek originates in the Lassen National Forest on the western slope of the Sierra Nevada Mountains. The creek is a tributary to the Sacramento River through two points: Butte Slough at Sacramento River Mile 139 near Colusa, and the Sutter Bypass and Sacramento Slough at Sacramento River Mile 80 near Karnak. The watershed ranges from 7,087 feet in elevation in the headwaters to approximately 150 feet at the Sacramento River points of entry and encompasses approximately 797 square miles (excluding the Sutter Bypass). Average annual unimpaired runoff is approximately 245,000 acre-feet, while imports from the Feather River, Sacramento River, and Little Chico Creek exceed 550,000 acre-feet annually. The Butte Slough and Sutter Bypass reaches of Butte Creek serve as a flood relief and convey all Sacramento River flows above approximately 25,000 cubic feet per second. The anadromous reach of Butte Creek is approximately 90 miles, extending from impassable natural barriers approximately 15 miles northeast of Chico to the bottom of the Sutter Bypass near Verona.

Butte Creek is one of only three tributaries to the Sacramento River that continues to harbor a sustaining population of the state and federally listed spring-run Chinook salmon. Major restoration actions (Table 1 and Figure 2) undertaken since about 1992 have significantly contributed to an increase in the spring-run salmon population (Figure 1) and reduced the potential for extinction. To date approximately \$35 million has been spent on restoration activities since 1992 (not including cost of multiple studies and technical evaluations). Significant commitments have been made to acquisition, physical monitoring, and management of instream flows. Actions include the M&T Ranch water exchange agreement, Durham Mutual water acquisition agreement, ten real-time flow gauging stations (Figure 2), and dedication of CDFG personnel to monitor and manage the acquired flows.
